copy annexed, adopted on November 23, 2018 by majority vote of the Board of Directors and by the vote of the stockholders owning or representing at least two-thirds of the outstanding capital stock, and certified under oath by the Corporate Secretary and a majority of the Board of Directors of the corporation was approved by the Commission on this date pursuant to the provision of Section 16 of the Corporation Code of the Philippines, Batas Pambansa Blg. 68, approved on May 1, 1980, and copies thereof are filed with the Commission.

Unless this corporation obtains or already has obtained the appropriate Secondary License from this Commission, this Certificate does not authorize it to undertake business activities requiring a Secondary License from this Commission such as, but not limited to acting as: broker or dealer in securities, government securities eligible dealer (GSED), investment adviser of an investment company, close-end or open-end investment company, investment house, transfer agent, commodity/financial futures exchange/broker/merchant, financing/lending company and time shares/club shares/membership certificates issuers or selling agents thereof; nor to operate a fiat money to virtual currency exchange. Neither does this Certificate constitute as permit to undertake activities for which other government agencies require a license or permit.

AMENDED'

ARTICLES OF INCORPORATION

OF

MANULIFE FINANCIAL PLANS, INC.

KNOW ALL MEN BY THESE PRESENTS:

THAT WE, all of legal age, majority of whom are residents of the Philippines, have this day voluntarily associated ourselves together for the purpose of forming a stock corporation under the laws of the Philippines.

AND WE DO HEREBY CERTIFY: That

FIRST. The name of said corporation shalf be MANULIFE FINANCIAL PLANS, INC., hereinafter called the "Corporation".

SECOND. The purpose for which the Corporation is organized and formed is:

PRIMARY PURPOSE

To create and provide a lawful institutional medium capable of developing, maintaining, conducting, operating, marketing, and selling any and all types of securities (without aeting as stock broker), including but not limited to life plans, education plans, pension, retirement income or retirement plans, with all the requisite facilities and services, merchandise or articles necessary or relevant to such securities and services to be delivered in the future to purchasers, subscribers, planholders and enrollees.

The Corporation shall have the following secondary purposes, powers and objects:

SECONDARY PURPOSES

 (a) To lease and maintain memorial parks or cemeteries with funeral chapels, to build, provide, equip and maintain crematories,

and to provide urns and other suitable vessels for cremated remains; to deal in and sell coffins and caskets and all such property, goods, wares and merchandise as are incidental to and used in the business of undertakers and morticians;

- (b) To act as managers, general agents, commercial brokers, advisers and representatives of and for any juridical person or for any other firm or enterprise lawfully engaged in business in or outside of the Philippines, with particular emphasis on insurance, health maintenance, managed care, home care agencies, custodial care, respite services, group home and assisted living services;
- (c) To develop, establish, provide, sell, market, hold and maintain various other educational programs not necessarily on a pre-need basis, such as but not limited to conventions, seminars, forums, convocations, conferences, lectures, exhibitions, educational films and shows;
- (d) To undertake researches, investigations and examinations of business and enterprises of every kind and description in the Philippines and throughout the world for the purpose of obtaining information and particulars on the investment and utilization of capital;
- (e) To enter into and transact all types of business related to the compilation of financial and investment data and statistics in the Philippines and throughout the world;
- (f) To own or otherwise acquire by deed, purchase or otherwise, the necessary property, building, and equipment essential or incidental to said business and to purchase, own, hold, possess, lease or otherwise acquire, and to use, operate, maintain, sell, pledge, mortgage, transfer or assign any real or personal property in the furtherance of the business and purpose of the Corporation;
- (g) To manufacture, (except food, drugs and cosmetics), buy, sell, deal in and to engage in, conduct and carry on the business of manufacturing, buying, selling at wholesale only and dealing in goods, wares, and merchandise of every class and description, including agricultural products, as may be permitted by the laws of the Philippines, and to act as agent, representative or attorney-infact of any individual, association, partnership, corporation or any other entity; to act as manufacturer's representative, commission merchant, merchandise broker, indentor, factor, consignment agent

or in any other representative capacity for natural or juridical persons or entities, whether domestic or foreign;

- (h) To carry on a general mercantile and commercial business of exporting, importing, wholeselling, jobbing or otherwise disposing of and dealing in any goods, wares, mercantile and commodities of all kinds, and various services and items ancillary thereto; to acquire by purchase or otherwise, and of owning, using, selling, granting, assigning and licensing others to use franchise of any business or retailing system;
- (i) Subject to existing laws, to organize and promote or assist in establishing, organizing, and promoting manufacturing, real estate and industrial enterprise, to acquire, construct, erect, lease, and operate plants, factory sites, and the machinery and equipment required for the operation of such enterprises, and generally to own, manage and/or administer lands, buildings, business of any kind, properties whether real or personal, and to construct and sell condominiums, as owner or as agent, representative or attorney-infact of owners thereof;
- (j) To borrow or raise money, negotiate loans from banks and financing institutions, domestic or foreign, for such amounts and under such terms and conditions as are just and reasonable, to make and issue notes, bonds or other evidence of indebtedness of all kinds, and to secure the same by mortgage, pledge or otherwise, in such amounts as the business of the Corporation may require;
- (k) To purchase, own, receive, collect or otherwise acquire, obtain any interest in, hold, pledge, hypothecate, mortgage, assign, deposit, create, trust with respect to, deal in, exchange, sell or otherwise dispose of, all kinds of shares, stocks, voting trust certificates, trust receipts, notes and other securities, obligations, choses in action and evidence of indebtedness, including promissory notes, drafts, bills of exchange, negotiable instruments and currencies of any person, partnership, association, corporation or entity, whether domestic or foreign;
- (I) To acquire shares, stocks, debentures, bonds, obligations, or securities of the Corporation, by purchase or otherwise, in so far as may be necessary to carry out its purpose, and to exercise and enforce all rights and powers conferred by or incident thereto;

- (m) To mortgage, encumber or hypothecate properties of the Corporation, real or personal, and to secure the payment of obligations of third persons, provided it will not engage itself in the surety business;
- (n) To invest its funds in other corporations; to raise, borrow, or arrange funds from private, institutional or government sources, local and/or abroad, subject to existing laws and regulations of the Philippines;
- (o) In carrying on its business and in order to obtain and further its powers or purposes, to do any and all other acts or things, and to exercise any and all other powers which a natural person might or could do and exercise and which now or hereafter may be authorized by law, as principal, agent, contractor, trustee or otherwise, either alone or in company with others, and, in addition, to have and to exercise all the rights, powers and privileges now or hereafter belonging to or conferred upon corporations under the provisions of the laws authorizing the formation of such corporation.
- (p) To do all such other things as are incidental or conducive to the attainment of the above objects or any of them, or which may be conveniently carried out and done in connection therewith or which may be calculated directly or indirectly to enhance the value of or render profitable any business or property of the Corporation.

THIRD. The place where the principal office of the Corporation is to be established is in 10F NEX Tower, Ayala Avenue, Makati City (As amended on 23 November 2018).

FOURTH. The term for which the said Corporation is to exist is FIFTY (5) YEARS from and after the date of Incorporation.
