1. Call to Order / Determination of Quorum

The Stockholders who joined in the meeting notified in advance the Corporate Secretary of their intention to participate in the meeting through remote communication. Inasmuch as 100% of the Stockholders were present at the meeting, a quorum was declared by the Corporate Secretary and the Annual Meeting of the Stockholders of The Manufacturers Life Insurance Co. (Phils.), Inc. was duly constituted and opened for transaction of the business on the agenda.

<u>Voting procedure</u> - All matters in the agenda subject to the vote of the Stockholders shall be decided by the majority vote of Stockholders present in person or by proxy, except in cases where the law provides otherwise. Each outstanding share of stock entitles the registered stockholder to one vote. The final tally of votes will be reflected in the minutes of the meeting.
